- 6) Minimum time taken to obtain Certificate of Clearance (CC)/ Certificate for Clearance & Tree Felling Permission (CC & TFP) in no. of days
- 7) Maximum time taken to obtain Certificate of Clearance (CC)/ Certificate for Clearance & Tree Felling Permission (CC & TFP) in no. of days
- 8) Average fee taken by the Department for completion of entire process of obtaining Certificate of Clearance (CC)/ Certificate for Clearance & Tree Felling Permission (CC & TFP).
- 9) A table showing Application No., Application date, Approval date, Fee details and total Fee Charged.
